Our aim is to endow each student with a vision of world mission based upon a fundamental knowledge of biblical principles in family ministry. We create a learning environment, which cultivates devoted leaders who will develop healthy families and improve the quality of people's lives. With skills for developing positive human relationships and cross-cultural education experience, students will be equipped to counsel individuals and families facing problems or in a crisis.

HIS University learning outcomes below are characteristically descriptive of our graduates. They are:

1. trained ***Family Ministers and Missionaries*** capable of communicating that all people are created in God's image and skillful in explaining that His desire is for everyone to belong to His family. Graduates acquire a Christian worldview and articulate how faith in God empowers their ability in the ministry of restoring marriage and family relationships;
2. professional ***Family Counselors*** who can skillfully counsel individuals and families and who are able to adapt their training in order to teach others in local and international churches, schools, and Christian or secular organizations;
3. capable ***Family Educators*** with a strong biblical background who can teach others in various stages of life.

HIS University believes in providing quality education coupled with dedication to Christian service. ### **Special Characteristics of HIS University**

1. While Korean is the primary language of instruction, some classes are in English with a Korean translator and a few MFT classes are in English. Some textbooks are in Korean while others are in English.

Korean language proficiency is determined by a pre-enrollment oral interview. English proficiency for the MFT Program is required. A translator may be provided for students for a fee. See the Registrar's office for more information.

2. Marriage and Family Therapy graduates are prepared for the California state exam for obtaining a license as a Marriage and Family Therapist (LMFT) administered by the California State Board of Behavioral Sciences (BBS) upon graduation. While most of the MFT classes are taught in Korean, the BBS Licensing Exam is in English, thus the MFT Program has an English Proficiency requirement.
3. Students participate in experiential learning in the classroom.
4. In-Person Education (IPE) held on campus and Distance Education (DE) held online are available to qualifying applicants.

### **ACCREDITATION STATUS**

HIS University is a member of the Transnational Association of Christian Colleges and Schools (TRACS) [15935 Forest Road, Forest, VA 224551; Telephone: (434) 525-9539; e-mail: info@tracs.org], having been awarded Accredited Status as a Category IV\* institution by the TRACS Accreditation Commission on April 28, 2035. This status is effective as of July 1, 2025, and is good through June 30, 2025.

TRACS is recognized by the United States Department of Education (ED), the Council for Higher Education Accreditation (CHEA), and the International Network for Quality Assurance Agencies in Higher Education (INQAAHE).

HIS University is approved to offer all of its programs and courses via Distance Education. Distance Education/courses are equivalent to on-campus programs/courses.

### Academic GPA and Probation

The Administrative Committee of HIS University shall declare a student on academic probation in the following events:

1. Undergraduate student's semester GPA falls below 2.0
2. Master's student's semester GPA falls below 3.0
3. Doctoral student's semester GPA falls below 3.3

The student will be placed on Academic Probation and allowed one semester to bring their GPA to the required average. Should the student achieve the appropriate overall GPA or better, they will be removed from Academic Probation status.

Should the student be unable to achieve the required grade point average in this time span, the student will be terminated for a minimum of one semester. The terminated student may re-enroll after one semester is completed. If accepted, the student will re-enter on Academic Probation for one semester during which time they should maintain the required grade point average or better. Students will not be removed from Academic Probation until both semester and total GPA is at required levels.

A grade point average should be maintained for all semesters while enrolled. (GPA is based on a 4.0 grading scale.) Any graduate student falling below a cumulative grade average of 3.0 and any undergraduate student falling below a 2.0 grade point average in any school semester will be placed on academic probation.

Students on academic probation for two (2) consecutive semesters are considered ineligible for scholarship funds that are available for the university to designate.

HIS University does not accept credits through challenge examinations and/or achievement tests.

### **High School Diploma or Equivalent**

Students who do not have a high school diploma, or a recognized equivalent, prior to accepting an enrollment agreement, will take and pass an independently administered examination. HIS University does not accept nor administer ATB tests. If such an exam is from another country, it must be equivalent to the US standard.

### **Life Experience**

Life Experience credit is not available at HIS University.

### **Program Length**

Seven years is the maximum allowance for completion of the Doctoral and Master programs. Four years is the maximum allowance for completion of the BA program, two years for the AA program and one year for the Diploma program. Students may appeal for an extension to the Program Director for consideration of a maximum allowance extension under extenuating circumstances. Extension of these completion dates is up to the sole discretion of HIS University.

Every two years HIS University offers all Doctoral and Master program courses. Every 4 years HIS offers the Bachelor of Arts program courses, every 2 years the Associate of Arts program courses and every year, the Diploma program course cycle. Dissertations and Practicums are not included in these course cycles as the student may determine their own schedule for these within the guidelines of the maximum allowance for completion of their respective degree programs.

### **Termination**

The Administrative Committee of HIS University shall refuse the application of any prospective student or may revoke the registration of any continuing student if that individual:

1. is convicted of a crime for an offense substantially related to the behavioral responsibilities of a minister or counselor.
2. fails to agree to or refuses to comply with any laws set by the state to regulate ministry or counseling practices.
3. falsifies admissions documents or commits multiple plagiarism offenses.

### **Units/Credits Defined**

**HIS University uses the term “units” for course credits.** In academia, these terms are often synonymous. At HIS University, ONE unit is earned for every 12.5 hours of class time. All semesters are 13 weeks with the exception of doctoral studies, which are 15 weeks. Independent Study hours may also be required at the doctoral level. (Example: 3 unit courses are attended 3 hours per week for 15 weeks; a total of 45 class hours.)

### **Units (Credits) Transfer**

HIS University has entered into articulation or transfer agreements with a variety of colleges and universities. Please contact HIS Registrar for details. Unit (Credit) Transfers are up to the discretion of the Academic Dean’s Office, which will evaluate them for comparability.

Maximum units transferrable into HIS programs are as follows: Doctoral Program - 12 maximum semester units; Master's Programs – 9 maximum semester units; Bachelor's Program – 44 maximum general education semester units and the Associate of Arts – 12 maximum semester units. No units are transferable into the diploma or certificate programs. HIS University will not accept or impose a benefit exam.

HIS University provides a dual-track program for the MFT and Doctoral Programs. If the student completes a doctoral program at HIS University and enters the MFT Program, 24 pre-requisite doctoral program units are allowed to be applied toward the course requirements of the MFT Curriculum. These course transfers and the dual-track MFT program must be requested by the student when they are approved and register for the MFT Program.

**NOTICE: Transferability of Units/Credits and Credentials Earned**

The transferability of credits into HIS University programs is at the complete discretion of HIS University. If the student chooses to transfer credits from HIS to another institution, acceptance into that institution's program in which the student is enrolling is also at the complete discretion of the institution to which the student may seek to transfer. If credits or the degrees, diplomas, or certificates earned at HIS University are not accepted at the institution where transfer is sought, it may be required that a student repeat some or all of the coursework at that institution. For this reason, attendance at HIS University must meet a student's educational goals. This may include contacting an institution where transfer is sought after attending HIS University to determine if the student's credits, degrees, diplomas or certificates will be accepted. For transferability of units/credits and credentials earned for each HIS University Program, see the details for each program as under Academic Programs in this catalog.

HIS University has articulation agreements with the following schools: (1) Beulah Heights Bible College in Atlanta, Georgia; (2) Midwest Theological Seminary in Wentzville, Missouri; (3) Southern California Bible College and Seminary in El Cajon, California; and (4) Shasta Bible College and Graduate School in Redding, California. Inquiries regarding these agreements may be requested from the Office of Administration.

**Visas for Students**

HIS University is approved by SEVIS to issue I-20 forms, which students use to acquire an F-1 Student Visa. HIS University follows the government requirements issued by Student and Exchange Visitor Information system (SEVIS).

**Withdrawal and Leave-of-Absence – See Student Manual for Details**

Registered DE students are required to participate face-to-face on video screen and audio. If they are not able to have audio and visual, they cannot be registered for a DE class. Students are expected to post feedback, suggestions, questions, reflections, as requested by the instructor, after each class within Google Classroom. These comments are verification for each student's weekly attendance. Professors read each entry and respond privately to each student on a weekly basis.

### **Class Interactions**

In addition to instruction in the virtual classroom, students and professors interact frequently using KakaoTalk. KakaoTalk (KT) commonly referred to as KaTalk in South Korea, is a mobile messaging app for smartphones. It is available on mobile and desktop platforms. Students and faculty receive updates, newsletters and announcements. Various chatrooms provide opportunities for further student and teacher communications. Professors are assigned to each chatroom.

### **Student Responsibility**

Students are expected to be able to access internet web sites, use online library resources and proficiency with Microsoft Word or similar word processing software. It is the student's responsibility to ensure that the browser used to access course material on their computer is compatible with the Google Classroom Platform. Problems in this area need to be discussed with faculty at the time of occurrence, either via a phone call during posted acceptable hours for calling, or via email notification during times outside those posted for calls.

### **Student Submits End of Course Evaluations**

At the end of this course, students will complete an anonymous End-of-Course Assessment. This is accessed by a link provided in the virtual classroom.

## **FINANCIAL INFORMATION**

### **Financial Aid**

HIS University is not eligible for federal financial aid programs. HIS University does not participate in any government or private financial aid programs. Limited scholarships are provided for missionaries and HIS University faculty members when funds are available. Please see Registrar for details.

### **Financial Loans – Important Information Regarding Student Loans**

If the student obtains a loan to pay for the university's educational program, the student will have the responsibility to repay the full amount of the loan plus interest, less the amount of any refund. If the student is eligible for a loan guaranteed by the state or federal government and the student defaults on the loan, both of the following may occur:

1. The federal or state government or a loan guarantee agency may take action against the student, including applying any income tax refund to which the person is entitled to reduce the balance owed on the loan.
2. The student may not be eligible for any other federal student financial aid at another institution or other government assistance until the loan is repaid.

3. HIS University is not a participant in the Federal Student Aid (FSA) loan program at this time.
4. HIS University does not participate in any State of California financial aid programs.

\*All newly enrolled California residents will be assessed a STRF fee of \$2.50 per \$1,000 charged for their program upon enrollment as required by California statute. However, as of April 1, 2024 there will be no STRF fees required until further notice from BPPE.

\*\*\*HIS University does not offer housing. Tutoring is not provided by the school however, tutors hired by students are allowed to sit in their classes at no charge.

**Refund Policy: Programs and Courses**

HIS University only offers face-to-face education. The student may withdraw from a course after instruction has started and receive a pro-rated refund for the unused portion of the tuition and other refundable charges if you have completed 60% or less of the instruction. The refund will be based on tuition paid and costs derived from the HIS Catalogue or the student entry year. The refund will be calculated as outlined by the State Educational Code. Tuition paid by a third party will be refunded to that party as described above. If HIS University cancels or discontinues a course or educational program, the

school will make a full refund of all charges unless a course or comparable program is substituted. If student has received federal student aid funds, the student is entitled to a refund of moneys not paid from federal student financial aid program funds. Refunds will be paid within 30 days of cancellation or withdrawal and require written notification.

**The student has the ability to cancel without financial obligation other than non-refundable fees, not to exceed \$250, no later than the first class of the of the semester. The students who choose to cancel enrollment should notify the school's administrative officer by written notice via mail.** The remaining tuition, (tuition charges remaining after subtracting the non-refundable fees already retained) will be refunded based on the course completion ratio and the tuition percentage listed below.

### **Right to Cancel**

Student withdrawal may be effectuated by the student's written notice or by the student's conduct, including, but not necessarily limited to, a student's lack of attendance. The student has the right to cancel the enrollment and obtain a refund.

If written notice of cancellation is made prior to or on the first day of instruction or the seventh day after enrollment, whichever is later, the institution shall refund all charges, less the deposit or application fee not to exceed one hundred dollars (\$100).

Cancellation shall occur when the student gives dated, written notice of cancellation at the address of HIS University shown on the cover of this catalog. The written notice of cancellation, if sent by mail, is effective when deposited in the mail properly addressed with postage prepaid and need not take any particular form. Refunds are paid within 30 days from receipt of written notice.

Cancellation initiated by HIS University that occurs because of a student's conduct, including, but not necessarily limited to, a student's lack of attendance, shall occur when the institution gives dated, written notice and reason for cancellation directly to the student. If sent by mail to the address provided at enrollment, the cancellation is effective when deposited in the mail properly addressed with postage prepaid and need not take any particular form.

### **STRF – Student Tuition Recovery Fund**

The State of California established the Student Tuition Recovery Fund (STRF) to relieve or mitigate economic loss suffered by a student in an educational program at a qualifying institution, who is or was a California resident while enrolled, or was enrolled in a residency program, if the student enrolled in the institution, prepaid tuition, and suffered an economic

loss. Unless relieved of the obligation to do so, you must pay the state-imposed assessment for the STRF, or it must be paid on your behalf, if you are a student in an educational program, who is a California resident, or are enrolled in a residency program, and prepay all or part of your tuition.

You are not eligible for protection from the STRF and you are not required to pay the STRF assessment, if you are not a California resident, or are not enrolled in a residency program.

It is important that you keep copies of your enrollment agreement, financial aid documents, receipts, or any other information that documents the amount paid to the school. Questions regarding the STRF may be directed to the Bureau for Private Postsecondary Education, 1747 North Market Blvd., Suite 225, Sacramento, California, 95834, (916) 574-8900 or (888) 370-7589.

To be eligible for STRF, you must be a California resident or enrolled in a residency program, prepaid tuition, paid or deemed to have paid the STRF assessment, and suffered an economic loss as a result of any of the following:

1. The institution, a location of the institution, or an educational program offered by the institution was closed or discontinued, and you did not choose to participate in a teach-out plan approved by the Bureau or did not complete a chosen teach-out plan approved by the Bureau.
2. You were enrolled at an institution or a location of the institution within the 120 day period before the closure of the institution or location of the institution, or were enrolled in an educational program within the 120 day period before the program was discontinued.
3. You were enrolled at an institution or a location of the institution more than 120 days before the closure of the institution or location of the institution, in an educational program offered by the institution as to which the Bureau determined there was a significant decline in the quality or value of the program more than 120 days before closure.
4. The institution has been ordered to pay a refund by the Bureau but has failed to do so.
5. The institution has failed to pay or reimburse loan proceeds under a federal student loan program as required by law, or has failed to pay or reimburse proceeds received by the institution in excess of tuition and other costs.
6. You have been awarded restitution, a refund, or other monetary award by an arbitrator or court, based on a violation of this chapter by an institution or representative of an institution, but have been unable to collect the award from the institution.
7. You sought legal counsel that resulted in the cancellation of one or more of your student loans and have an invoice for services rendered and evidence of the cancellation of the student loan or loans.



To qualify for STRF reimbursement, the application must be received within four (4) years from the date of the action or event that made the student eligible for recovery from STRF.

A student whose loan is revived by a loan holder or debt collector after a period of non-collection may, at any time, file a written application for recovery from STRF for the debt that would have otherwise been eligible for recovery. If it has been more than four (4) years since the action or event that made the student eligible, the student must have filed a written application for recovery within the original four (4) year period, unless the period has been extended by another act of law.

However, no claim can be paid to any student without a social security number or a taxpayer identification number.

## **GENERAL INFORMATION**

The Transnational Association of Christian Colleges and Schools (TRACS) is recognized by the United States Department of Education (USDE), the Council for Higher Education Accreditation (CHEA) and the International Network for Quality Assurance Agencies in Higher Education (INQAAHE) as an institutional accrediting agency for Christian institutions, colleges, universities, and seminaries offering certificates, diplomas, and associate, baccalaureate, and graduate degrees.

HIS University was awarded Accredited status as a Category IV institution (approved to award degrees through the doctoral level by the TRACS Accreditation Commission.

HIS does not operate any Branch Campuses and does not operate any Teaching Sites.

HIS University is a legally established, California non-profit corporation under section 40(c)(3) of the Internal Revenue Service Code and 23701d of the State of California Revenue and Taxation code. HIS University is governed by a volunteer Board of Directors which sets policies and manages the institution.

### **Changes in the Catalog**

HIS University reserves the right to revise information in the catalog as necessary, including changes in curriculum, personnel, procedures, policies, and fees. HIS is subject to all changes requested by the State of California as represented by the Bureau for Private Postsecondary Education (BPPE) or by the Federal Government. Changes will be noted as catalog addendums on the HIS website if they occur before the publishing of the next year's new catalog.

School building access is open at various hours. Please check with the office for current schedules. School equipment may not be removed or used without permission from the COO.

### **Grievance Procedure – See Student Manual for Details**

At times, differences in interpretation of school policies occur among students, faculty, and/or administrative staff. When this happens, we urge all involved parties to communicate any problems directly to the individual(s) involved. Normally miscommunication and misunderstanding can be cleared during such “discussions” and the problem resolved. If necessary, the appropriate Departmental Director should be contacted for assistance. If an understanding is unable to be reached, Student Grievance Review Request forms are available at the Reception Office. Once completed and turned into the Departmental Director, it will be presented to the Administrative Committee (ADCOM) for review. Their final decision will be provided to the student.

An average of \$2,200 to \$2,800 monthly rent is usually required with one to three month's rent pre-deposit for apartments. Also, various single-room housing options are available. A monthly fee of \$900-\$1,200 is required with breakfast and dinner included. A monthly fee of \$600-\$700 is required without meals. **Plagiarism**

Plagiarism is both unacceptable and inexcusable. The Academic Dean will determine the appropriate action for any such offense.

**Student Code of Conduct**

A student may be failed or dismissed for academic dishonesty, or acts or inattention that violate professional ethics in patient care. At the discretion of the Academics Dean and

Administrative Committee, a student may be dismissed from the university for behavior disruptive to the educational mission of the university, such as, but not limited to, those stated below:

- \* Cheating, bribery, or plagiarism in connection with an academic program;
- \* Forgery, alteration or misuse of university documents, records or identification, or knowingly furnishing false information to the university.
- \* Misrepresentation of oneself or an organization to be an agent of the university;
- \* Obstruction or disruption on or off-campus property, of the campus educational process administrative process, or other campus function;
- \* Physical abuse, on or off campus property, of the person or property of any member of the campus community, or members of this/her family or the threat of such physical abuse;
- \* Theft of or non-accidental damage to university property or property in the possession of or owned by a member of the university community;
- \* Unauthorized entry into, unauthorized use, or misuse of university property;
- \* Sale or knowing possession of dangerous drugs, restricted drugs, or narcotics, as those terms are used in California statutes, except when lawfully prescribed pursuant to medical or dental care, or when lawfully permitted for the purpose of research, instruction or analysis;
- \* Lewd, indecent, or obscene behavior on university property or at a university function;
- \* Abusive behavior directed toward a member of the university community;
- \* Violation of any order of the university President, notice of which has been given prior to such violation and during the academic term in which the violation occurs, either by publication or by posting on an official bulletin board designed for this purpose, and which order is not inconsistent with any of the other provision of this section;
- \* Soliciting or assisting another to do any act that would subject a student to dismissal, suspension, or probation pursuant to this section.

The President of HIS University, at his/her discretion and prior to recommendations or actions of the Administrative Committee, in the interests of the university may place on probation, suspend or dismiss a student for one or more of the causes enumerated above. Any adjustment of fees or tuition shall be those required by law.

### **Student Records**

Student Records policy is based on current requirements of the California Private Postsecondary Education Act of 2009 (section 94900). HIS University maintains the name, address, e-mail address, and telephone number of each student who is enrolled in its educational program. HIS University maintains for each student granted a degree, diploma or certificate, permanent records of the following:

- 1) The degree, diploma and/or certificate granted and the date earned.
- 2) The courses and units on which the degree, diploma or certificate was based.
- 3) The grades earned by the student on each course taken.
- 4) Academic files and financial records are maintained separately for a period of five years after their graduation date or date of withdrawal.

The university's policy is to maintain the confidentiality of student academic records. No one outside of the institution shall have access to, nor will the university disclose, any information from a student's academic records without the written consent of the student except:

- School officials with legitimate educational interest;
- Other schools to which a student is transferring, specified officials for audit or evaluation purposes;
- Appropriate parties in connection with financial aid to a student;
- Organizations conducting certain studies for or on behalf of the school;
- Accrediting organizations;
- To comply with a judicial order or lawfully issued subpoena; and
- Appropriate officials in cases of health and safety emergencies.

The student's academic file is the sole property of HIS University. The university will not release copies of documents of course work from other institutions attended. Further information is provided online at <http://studentprivacy.ed.gov/> or in the FERPA bulletin handout, family educational rights and privacy policies of HIS University which are available in the Reception Office. Students who believe that academic records contain inaccurate or misleading information may discuss their concerns informally with the Registrar. If the decisions are in agreement with the student's request, the records will be amended. If not, the student may follow additional procedures outlined in the privacy policies bulletin (FERPA) noted above.

### **Student Services**

A Student Council assists in communication between the general student body and HIS University.

The HIS University Administration Office personnel provide personal assistance to students as needed. If necessary, referrals are made to appropriate HIS University staff.

### **Transcripts and Records**

ALL financial obligations to HIS University must be met before any transcript, diploma or certification is issued. Transcript requests must be submitted in writing, dated, signed and paid for by the student. Verbal requests for transcripts are not accepted.

### **Withdrawal Grades**

- A “W” indicates an official withdrawal from a course. The student’s grade at the time is not averaged into the student’s grade average.
- A “LW” indicates a late withdrawal. Students who withdraw after the deadline for dropping a course will receive a “LW” grade (LWA, LWA-, LWB+, etc.). This will influence the grade average the same as an official grade.
- Students who register for a class but do not attend it automatically receive an Unauthorized Withdrawal grade of “UWF” which will receive a course grade as an “F”.

## DOCTOR OF PHILOSOPHY

### Family Ministry

#### **Program Description**

The Doctor of Philosophy degree in Family Ministry is designed to equip highly competent professionals to conduct research, publish and teach. The degree emphasizes family ministry components of education and places a strong emphasis on family ministry leaders' training.

#### **Mission Statement and Program Learning Outcomes**

The preventative and healing ministry for family is an urgent mission for the whole world; every country, community, church and mission organization. The Doctor of Philosophy degree in Family Ministry equips student to become highly competent professionals who conduct research, publish and teach. The student will synthesize family ministry components of education as they research and adapt their education to the training of family ministry leaders.

The graduating student of HIS University's Ph.D. in Family Ministry will be able to:

1. explain the definition and communicate an understanding of Family Ministry;
2. create and facilitate family ministry leadership training environments and programs;
3. integrate Family Ministry training into their own existing and future professions;
4. design research, writings, and speeches on family ministry.

#### **Graduation Requirements**

A student must complete 60 units of the Ph.D. program curriculum to be eligible for graduation.

(A maximum of 12 transfer units is allowed.) Prior to graduation approval, the student must also:

1. Completion of 60 required curriculum units with a GPA of 3.3 in all coursework.
2. Completion of all units within a seven (7) year time span from date of entry.
3. Pass a comprehensive exam.
4. File an application for intent to graduate with the school office 6 weeks prior to graduation to certify that all graduation requirements have been met.
5. Orally defend and submit an approved dissertation.
6. Submit the required copies of the bilingual dissertation.

#### **Program Description**

The graduates will acquire the vision and tools to help communities to develop "healthy families" where members trust, support and empower each other.

The graduating student of the Doctor of Education Degree in Christian Education and Counseling will be able to:

1. provide for the development of Christian leaders equipped to demonstrate their ability to design and implement counseling programs in the international and local church, school and community;
2. adapt and teach the program specific content knowledge and skills in the development and support of healthy individuals, couples, families and children's mental health;
3. exhibit their ability to conduct independent research to answer relevant questions in their area of specialization and add to the body of knowledge in the field of education.

#### **Graduation Requirements**

5. Orally defend and submit an approved dissertation

### **Marriage and Family Therapy**

(This program completion is available In-Person Education only.  
Some classes may be taken online.)

#### **Program Description**

The Master in Marriage and Family Therapy program prepares students to serve as culturally and socially responsive therapists in both public and private sectors. Students will demonstrate an ability to address a range of challenges including relationship stressors, family dysfunction, and behavioral difficulties in individuals, couples and families. Upon completion of the program, students will be eligible to obtain licensure in California as a Marriage and Family Therapist (LMFT).

#### **Mission Statement and Program Learning Outcomes**

The mission of the Master of Arts Program in Marriage and Family Therapy is to equip students to become Licensed Marriage and Family Therapists. Students are provided knowledge and experience to apply in their training as professional therapists as they utilize their new skills in counseling and therapy settings.

The graduating student of the M.A. in Marriage and Family Therapy will be able to:

1. synthesize theoretical and practical training that qualifies them to become Licensed Marriage and Family Therapists;
2. relate the academic and theoretical realm to the professional realm as professional therapists who are capable of counseling individuals, couples, families, and children;
3. register with the Board of Behavioral Sciences (BBS) as Associate Marriage and Family Therapists under the guidance of Approved and Certified Supervisors.

#### **Graduation Requirements**

A student must complete 67 units of the required MFT Program curriculum to be eligible for graduation. (A maximum of 12 transfer units is allowed.) Prior to graduation approval, the student must also:

1. Complete the 67 required curriculum units with a minimum GPA of 2.0 in all coursework.
2. Complete all units within a seven (7) year time span from date of entry.
3. Complete a comprehensive exam or course option.
4. File an application for intent to graduate with the school office 6 weeks prior to graduation to certify that all graduation requirements have been met,
5. Fulfill MFT Policy Language Requirements: TOEFL Score PBT550 or IBT 80 above and Equivalent (MFT Degree Only).

Acquiring an MFT License in the State of California (only)

In addition to completion of HIS University requirements for graduation, the Board of Behavioral Science (BBS) states that effective January 1, 2016, graduates seeking licensure must:

- successfully pass a California law and ethics examination. An applicant who has successfully passed a law and ethics examination may be subsequently required to take and pass another written examination.
- not have committed acts or crimes constituting grounds for denial of licensure under Section 480. The board shall not issue a registration or license to any person who has been convicted of a crime in this or another state or in a territory of the United States that involves sexual abuse of children or who is required to register pursuant to Section 290 of the Penal Code or the equivalent in another state or territory.

## **Counseling**

### **Program Description**

The counseling major will have opportunity to identify and integrate a broad spectrum of issues concerning human nature and the function of a distinctly Christian worldview. The student will acquire an ability to communicate various aspects of research and theories of counseling, qualifying them for graduate studies in the field.

### **Mission Statement and Program Learning Outcomes**

The mission of the Bachelor of Arts in Counseling is to enable graduates to integrate current theory on human nature and their own developed Christian worldview. Ultimately, this foundation in counseling prepares graduates for the pursuit of a career in ministry, business and other professional areas and qualifies them for further studies in graduate school.

The graduating student of the Bachelor's Degree in Counseling will be able to:

1. demonstrate the basic character and knowledge of Christian counselors with a Biblical worldview;
2. provide themselves and others the ability to resolve issues and/or crisis in individual, families, churches and other communities;
3. demonstrate knowledge of current theories of counseling that provide a foundation for equipping them to become professional counselors.

### **Graduation Requirements**

A student must complete 120 semester units to be eligible for graduation. Generally, the student must complete the following:

1. Complete 120 semester units with a GPA of 2.0 in all coursework. A maximum of 80 transfer units is allowed. (Quarter units may be converted to semester units by multiplying by two-thirds.)
2. Complete all units within a four (4) year time span from date of entry.
3. File an application for intent to graduate with the school office 6 weeks prior to graduation to certify that all graduation requirements have been met.

#### ***\* Total units required for graduation***

A minimum of 120 units is required. No more than 80 units taken at a community college or other two-year college may be applied to this total, excluding military credit and credit by examination, which are not included in this limit. Quarter units may be converted to semester units by multiplying by two thirds.

#### ***\* Upper Division units required for graduation***

Completion of at least 40 of the total units must be upper division. HIS University *lower division courses* are numbered 100-199; *upper division courses* are numbered 200-299. ## **Peer Christian Counseling**

### **Program Description**

The primary purpose of the Diploma in Peer Christian Counseling is to train students for an effective ministry of integrating Christian faith and counseling.

### **Mission Statement and Program Learning Outcomes**

The mission of this program is to train students to serve as peer counselors for the local church, in schools, the mission field and other organizations. Graduates are prepared to guide peers in the area of mental health related issues with their basic knowledge of assessing and referral to professional counselors.

The graduating student of the Peer Christian Counseling Diploma will be able to:

1. train members of local churches, Christian organizations and communities to become peer Christian counselors;
2. assess the mental health status of themselves and their neighbors. As peers, on a first aid level, discern when and how to refer individuals for professional counseling;
3. know how to identify and apply techniques for dealing with suicide prevention, addictions, self-harm, or harm toward others, caused by mental health problems.

### **Graduation Requirements**

A student must complete 24 semester units. (No transfer units are allowed into this program)  
Generally, the student must complete the following:

1. Complete 24 semester units with a GPA of 2.0 in all coursework. Completion of all units within a three (3) year time span from date of entry.
2. File an application for intent to graduate with the school office 6 weeks prior to graduation to certify that all graduation requirements have been met.

## **COURSE DESCRIPTIONS**

### **DOCTOR OF PHILOSOPHY IN FAMILY MINISTRY**

#### **DFM700 *Family Education and Counseling Research* (4)**

In this course, students will discover research methods and principles in the area of the marriage and family education and counseling in order to develop a dissertation in the field. Family education topics, such as human development from birth to death and various topics on marriage counseling are distinguished. Students will discover family ministry program design, reflect on and compare cultural issues, marriage education programs, family ministry leaders' training issues, and participate in experiential learning approaches. Students will hypothesize how to actively research marriage and family education and counseling through qualitative and quantitative approaches. This course will stimulate students to decipher research options for their own dissertation proposals by integrating course content with personal interests and experiences. Students will analyze current issues related to culture change and/or social and academic demands in relation to their areas of research.

#### **DFM710 *Biblical Studies in Family Ministry* (4)**

Marriage and family is established by God's design, not man's. The Bible provides the theological foundation for family ministry. This course presents biblical study and research as an indispensable guide and resource for training family ministry leaders. The program covers spiritual resources and insights into a biblical understanding of the family, providing guidance on the establishment of emotionally and spiritually strong and healthy nuclear family and the church, as a bigger family. Family ministry is a Kingdom Ministry expanding the Kingdom of God, as one theme throughout whole bible.

#### **DFM720 *Advanced Pastoral Counseling* (4)**

This course provides an overview of theoretical and Biblical approaches to Pastoral Counseling. The focus of this study is on developing counseling skills needed to assist individuals to deal with their physical, relational, spiritual, emotional and moral reality. Concentration is also on developing skills needed to facilitate individuals to take responsibility for their own lives and grow in Christian maturity and personal ministry.

**DFM730 *Family Ministry Program Development* (4)**

In today's fragmented and frenetic world, families face all kinds of pressures. Accordingly, those in family ministry need a multifaceted, well-informed sense of the Christian family's purpose and of the complex world these families inhabit. Family ministry leaders have the responsibility of designing and implementing family ministry in the local church and in the mission field. Through research and practice, this course provides knowledge, tools and insight into the development of family ministry programs. The course offers an understanding of how to plan and lead family ministry through evaluation and assessment in the context of community.

**DFM731 *Team Ministry Research* (4)**

This team building course is designed to equip leaders in the development of their relational strategies within the context of church and community. Exploration of the dynamics of effective work teams, the development, maintenance, and benefits of leadership teams in family ministry settings is provided. Content includes a focus on team assignment, strategies for team development, beneficial leadership practices, and the application of team strategies to various local and cross-cultural ministry settings.

**DFM740 *Special Topics: Child Abuse Workshop* (1)**

This workshop fulfills the Board of Behavioral Sciences 7- hour requirement for training on how to provide services to victims of child abuse. Content is examined that is related to child abuse, historical precedents and other sociological factors of child abuse and an examination of Christian faith and its response to child abuse.

**DFM741 *Special Topics: Alcoholism and Substance Abuse* (1)**

This course includes a range of specialized topics that are of interest to mental health professionals. The course provides training in providing services to those suffering from alcoholism and substance abuse. Medical and social overviews are examined in the context of Christian faith.

**DFM742 *Special Topics: Domestic Violence* (1)**

The topic of this workshop includes the effects of domestic violence on adults and children, practical counseling solutions, legal issues, and social factors of domestic violence in the context of Christian faith. Preventative strategies against domestic violence are explored.

**DFM743 *Special Topics: Psychopharmacology* (2)**

This topic discusses the various pharmaceutical drugs and their appropriate use in cooperation with counseling in the treatment of psychological disorders.

**DFM744 *Special Topics in Family Studies* (4)**

This course studies special topics as they relate to human development in the family system circle. These may include psychology of exceptional children, Alzheimer's disease, aging, memory loss, etc.

**DFM750 *Research Design* (4)**

This course covers research methods and principles in the area of the education of family. Human development birth to death will be covered. Content is specifically designed for designing a dissertation in the field of counseling and education. (Prerequisite: Research Methods)

**DFM721 *Alcoholism & Substance Abuse***

Special topic courses offer graduate level content that is typically scheduled in an intensive format. These courses include a range of specialized topics that are of interest to mental health professionals. Among these topics are the alcohol and substance abuse. Students are taught skills which enable them to access and treat alcoholism and substance abuse as they become mental health professionals. This course focuses on the DSM 5 diagnostic criteria of Alcoholism and Substance use disorders. No Prerequisites.

**DFM780/781 *Advanced Field Experience I* (3) and *Advanced Field Experience II* (3)**

During the final year of study, students participate in an internship designed to give the student practical training experience under the direction of a competent and experienced pastor or Christian counselor. These practicums provide more intensive participation in the areas of family leadership and Christian counseling.

**DFM790 *Dissertations* (8)**

This course concentrates on writing the student's doctoral dissertation. The student will be required to develop a topic outline using the material developed in the methods seminar and then write the dissertation under the guidance of a faculty member.

**DOCTOR OF EDUCATION IN CHRISTIAN EDUCATION**

**EDD701 *Family Education and Counseling Research Design* (4)**

This course covers research methods and principles in the area of the marriage and family education and counseling. Content includes human development, from birth to death, for family education as well as various topics on marriage counseling. The students will have opportunity to learn how to research in the area of marriage and family education and counseling through qualitative and quantitative approaches. This course stimulates students to research for the dissertation proposal, integrating their interests and experiences.

**EDD702 *Special Topics in Family Studies* (4)**

This course studies special topics as they relate to human development in the family system circle. These may include psychological and/or theological research in current issues such as children, youth, couples, elders, and/or human development in the family system. Consulting with the professor, students will be able to recommend special topics related to their ministries and other topics in which they are interested.



**EDD703 *Advanced Child & Adolescent Counseling* (4)**

This course provides students practical skills in the area of child and adolescent education and counseling through experiential learning approaches. This course presents developmental theory for children so students are more effective in education and counseling. The students learn how to test the intellectual and personality traits of a child in order to have a basic understanding him/her. This course examines normal and abnormal behaviors, identifies common issues with counseling skills and techniques, which are most beneficial for children and adolescents.

**EDD704 *Counseling Training Program Development* (4)**

One of the objectives of the Ed.D. in Counseling program of HIS University is to train the students to be a director of counseling departments of their local churches and/or other organizations. The graduates are equipped with the knowledge and skills to train counselors. This course provides the students with a basic understanding of how to train effective counselors, lead in preparation of strategic plans and curriculum development.

**EDD705 *Supervision Skills for Counselors* (4)**

This course provides the students with the theories and skills to be a supervisor for counselors. Supervising is one of the essential elements in counselors' training process. It includes observation, evaluating, training, guiding and mentoring providing oversight to trainees using relational or systematic approaches for the purpose of helping them attain systemic clinical skills.

**EDD710 *Advanced Adult and Senior Education and Counseling* (4)**

This course examines in depth the current theories of adult and senior education including issues related to current literature. Emphasis will be placed on social and cultural issues while dealing from holistic aspects for producing the best results in adult and senior education and counseling.

**EDD720 *Advanced Abnormal Psychology* (4)**

This course explores the symptoms and causes of various types of psychological disorder, particularly the neurotic, psychotic, and mood disorders. A Psychodynamic understanding of these abnormal conditions is emphasized. How we define, assess, and study abnormality are important underlying issues. A variety of class exercise including small group activities, group discussion, group presentation, internet DVD, and DVDs are used to help students understand mental disorders.

**EDD721 *Alcoholism & Substance Abuse***

Special topic courses offer graduate level content that is typically scheduled in an intensive format. These courses include a range of specialized topics that are of interest to mental health professionals. Among these topics are the alcohol and substance abuse. Students are taught skills which enable them to access and treat alcoholism and substance abuse as they become mental health professionals. This course focuses on the DSM 5 diagnostic criteria of Alcoholism and Substance use disorders. No Prerequisites.

**EDD730 Research Design (4)**

This course covers research methods and principles in the area of the education of family. Human development birth to death will be covered. Content is specifically designed for designing a dissertation in the field of counseling and education. (Prerequisite: Research Methods)

**EDD780/781 *Advanced Field Practicum I* (3) and *Advanced Field Practicum II* (3)**

During the final year of study, students participate in an internship designed to give the Christian Educator practical training experience under the direction of a competent and experienced pastor or Christian counselor. This practicum provides intensive participation in the areas of educational leadership and Christian counseling.

**EDD790 *Dissertation* (8)**

This course concentrates on writing the student's doctoral dissertation. The student will be required to develop a topic outline using the material developed in the methods seminar and then write the dissertation under the guidance of a faculty member.

**MASTER OF ARTS IN MARRIAGE AND FAMILY THERAPY****MFT500 *Research Methods* (1)**

The course surveys the major social science research methods, preparing students to design and implement a testable research proposal and to review and utilize professional literature.

**MFT509 *Philosophical Foundations of Psychotherapy* (3)**

This course introduces students to the philosophical analysis of the anthropologies embedded within psychotherapeutic systems. Key issues in both the formation of moral selfhood and the development of a biblical anthropology are identified. Students are encouraged to develop a view of human nature that demonstrates theological consistency and clinical applicability.

**MFT510 *Cross-Cultural Education and Family* (3)**

Advanced course dealing with marriage and family education and counseling integrated with principles and practices of cross-cultural education. It is an experiential learning approach to family ministry leaders' training designed to meet preventive and healing ministry in scriptural context.

**MFT511 *Interpersonal and Intercultural Relationships* (3)**

A study of the development and maintenance of healthy relationships. Topics of discussion include application of biblical principles to life situations, different personalities, development of skills in conflict management, and living in a group setting and being part of a team.

**MFT512** *Legal, Ethical and Moral Issues in Therapy* (3)

This course introduces students to the moral foundations, ethical responsibilities, and California laws essential to the practice of clinical psychology and marital and family therapy. Ethical codes and the resolution of moral dilemmas are studied from the perspective of the Judeo-Christian ethical tradition.

**MFT513** *Group Counseling* (3)

A study in learning theory related to group counseling. The course will introduce the art of helping others to gain deeper insight and better understand themselves through experiential learning exercises and assignments that include group feedback and results in modified behavior.

**MFT514** *Marriage and Family Counseling* (3)

This course is an in-depth study of family structure, function, and dynamics from a family systems perspective in relation to family dysfunction and approaches to family intervention. Assessment techniques and analysis of marital relationships, with cultural variables influencing communication, human intimacy, and interpersonal dysfunctions are studied from different perspectives.

**MFT540** *Special Topics: Child Abuse Workshop* (1)

This workshop fulfills the Board of Behavioral Sciences 7- hour training requirement on how to provide services to victims of child abuse. Also examined are contexts for child abuse, historical precedents and other sociological factors of child abuse and an examination of Christian faith and its response to child abuse.

**MFT541** *Special Topics: Domestic Violence Workshop* (1)

The topics of this workshop include the effects of domestic violence on adults and children, practical counseling solutions, legal issues, and social factors of domestic violence in the context of Christian faith. Preventative strategies against domestic violence are explored.

**MFT542** *Special Topics: Psychopharmacology* (2)

This topic discusses the various pharmaceutical drugs and their appropriate use in cooperation with counseling in the treatment of psychological disorders.

**MFT543** *Special Topics: Aging and Long-term Care* (1)

This topic is required by the California Board of Behavioral Sciences (BBS) for the MFT license. This course related to taking care of seniors in aging and their aging related problems.

**MFT551** *Theories of Personality and Psychotherapy* (3)

This course surveys the basic theoretical orientations used by current practitioners, focusing on theories used in treatment of individuals within a system. Established schools of thought will be studied and critiqued.

**MFT552 *Human Sexuality and Sex Therapy* (2)**

This course reviews human sexuality as a basis for sex therapy. Students examine and evaluate the biological, psychological, social, and moral perspectives of the theories of sexual development and functioning.

**MFT557 *Marital Therapy* (3)**

A study of the psychotherapeutic theories utilized in the clinical assessment and treatment of marital dysfunction is covered in this course. Models of a healthy marriage are also studied. Reading specific books and journal articles, as well as conducting a psychological assessment of couples is required.

**MFT558 *Advanced Developmental Psychology* (3)**

This course utilizes a lifespan perspective to consider individual development as it occurs within the family and family development as composed of individuals. Biological, psychological, social, and moral development are studied. Psychoanalytic, cognitive, and ecological systems models of development are presented.

**MFT561 *Child and Adolescent Therapy* (3)**

This course provides an understanding of the broad range of childhood and adolescent problems and disorders. A variety of psychotherapeutic modalities is presented, offering the student an opportunity to develop knowledge of basic child and adolescent therapy skills, assessments, and treatment strategies.

**MFT563 *Psychopathology* (3)**

This course provides a survey of the major theories, categories, and treatment of psychopathology. Through the use of case studies, students develop their diagnostic skills and a mastery of concepts in the Diagnostic and Statistical Manual of Mental Disorders.

**MFT564 *Severe Mental Illness* (3)**

This course explores the symptoms and causes of various types of psychological disorders particularly the neurotic, psychotic, and mood disorders. A psychodynamic understanding of these abnormal conditions is emphasized. A variety of class exercises including small group activities, group discussion, group presentation internet clips are used to understand mental disorders on severe mental problems.

**MFT571 *Family Therapy* (3)**

This course consists of an overview of current theories and methods of family intervention. The systems approach is emphasized, though psychodynamic and communication concepts in the interpersonal field are also included. The major theorists in each system are identified and their techniques demonstrated.

**MFT577 *Psychological Assessment Skills and Test* (3)**

This course provides students with a broad understanding of the clinical use of psychological tests, including projective personality tests, intelligence tests, and projective testing devices. Emphasis is placed on developing skills in interviewing, understanding and interpreting test data and reports, and gaining knowledge of referral questions, as well as writing integrated reports and providing feedback to examinees.

**MFT580** *Introduction to Clinical Practice I: Basic Skills* (3)

This course introduces the student to basic skills in attending behavior, clinical interviewing, treatment planning, progress notes, clinical intervention, and medical/psychiatric consultation and referral.

**MFT581** *Introduction to Clinical Practice II: Advanced Skills* (3)

This course is designed to further develop the psychotherapeutic skills of students prior to their entry into a clinical placement. Students focus on developing proficiency in the core interviewing qualities, deriving goals for clinical sessions, and in making contracts with clients for change.

**MFT595** *Special Topics: Alcoholism and Substance Abuse* (1)

Special courses offer graduate level content that is typically scheduled in an intensive format. These courses include a range of specialized topics that are of interest to mental health professionals. Among these topics is the Substance Abuse Course. Courses range from 1 to 6 units depending upon the specific contact hours and workload involved in the course.

**MFT596** *Family Crisis Counseling* (3)

Theoretical and practical issues of counseling families in crisis in the context of Christian experience are developed in this course.

**MFT597/598** *Clinical Placement I* (3) *and MFT Clinical Placement II* (3)

During the final year of study, students participate weekly in a practice class, clinical field placement, and supervision session. In the classroom, students discuss and practice the clinical application of psychological theories to clients seen in their field placement. Students receive feedback from instructors and other students in response to role playing and audio/videotaped client sessions. In the clinical placement, students develop skills through direct treatment of individuals, couples, families, and children. Course I begins after the student has completed 12 units but no later than the first week of their final year of study.

**MASTER OF ARTS IN CHRISTIAN COUNSELING**

**MCC500** *Research Methods* (3)

The course introduces the student to the process of scholarly inquiry in counseling, theology and ministry-related areas, including general, qualitative and quantitative research methodology. Also included is instruction on the preparation and presentation of academically researched papers and projects. Broad research approaches are examined. Special emphasis is given to the development of skills in using the library and its resources,

and research writing. The course will include sample reading of counseling and theological literature and development of a model research paper.

**MCC510** *Cross-Cultural Education and Family Ministry* (3)

Advanced course dealing with marriage and family education and counseling integrated to principles and practice of cross-cultural education. It is an experiential learning approach to family ministry leaders' training designed to meet preventive and healing ministry in a scriptural context.

**MCC511** *Interpersonal and Intercultural Relationships* (3)

A study of the development and maintenance of healthy relationships. Topics of discussion include application of biblical principles to life situations, different personalities, development of skills in conflict management, and living in a group setting and being part of a team.

**MCC514** *Christian Marriage and Family Counseling* (3)

This course is an in-depth study of family structure, function, and dynamics from a family systems perspective in relation to family dysfunction and approaches to family intervention. Assessment techniques and analysis of marital relationships, with cultural variables influencing communication, human intimacy, and interpersonal dysfunctions are studied from different perspectives.

**MCC561** *Marital Counseling* (3)

This advanced course deals with problems and conflicts within marriage and family settings. Counseling methods and practical behavioral methods from a scriptural context designed to meet problems and conflicts; conducted via demonstrations, case studies and counseling involvement.

**MCC551** *Human Growth and Development* (3)

An overview is provided regarding the theories and stages of human growth and development from birth to adulthood. This course examines the various stages of emotional, physical, sociological, cognitive, and spiritual growth.

**MCC521** *Alcoholism & Substance Abuse*

Special topic courses offer graduate level content that is typically scheduled in an intensive format. These courses include a range of specialized topics that are of interest to mental health professionals. Among these topics are the alcohol and substance abuse. Students are taught skills which enable them to access and treat alcoholism and substance abuse as they become mental health professionals. This course focuses on the DSM 5 diagnostic criteria of Alcoholism and Substance use disorders. No Prerequisites.

**MCC522** *Adolescent Psychology* (3)

This course studies the psychological growth processes of the adolescent. Included is an investigation of the theoretical and theological issues within the field of adolescent psychology.

**MCC524 *Gender and Sexuality* (3)**

This study provides a study of the relationships between social interaction processes and individual behaviors of the different genders of human beings. The course familiarizes the student with a variety of perspectives on social behavior and encourages the student to become a careful observer of social interaction through systematic research.

**MCC532 *Communication Issues* (3)**

A survey of the basic communication processes applied to human interaction. Various topics may include group communications, conflict resolution and leadership.

**MCC533 *Cultural and Ethnic Issues* (3)**

This course studies the A study of concepts, skills and attitudes useful in adapting to life in other cultures including inter-cultural communication, values, customs, etc.

**MCC541 *Spirituality in Family Life* (3)**

This course investigates the Biblical principles of family life. Values, mature religion, the nature of humanity, and religious experience are all areas of study for this purpose.

**MCC545 *Family Therapy* (3)**

This course studies the field of therapy for the family in crisis. Communication, conflict resolution, system analysis are the some of the various topics to be discussed.

**MCC550 *Spirituality in Therapy* (3)**

This course provides an investigation of the biblical principles concentrating on the mental health of the human adult. A common ground will be studied between psychology and the Christian faith.

**MCC555 *Child and Youth Counseling* (3)**

This course examines normal and abnormal adolescent behaviors, identifies common adolescent issues, symptoms and presents counseling techniques and skills resulting in the ability to work with adolescents. Family and peer relationships are explored as well as school influences.

**MCC560 *Christian Counseling and Psychotherapy* (3)**

This course provides the students with general understanding of the integration between Christian counseling and psychotherapy. The classes focus is on the analytical psychology of Jung as it relates to Christian integrity based on the Bible. This course also deals with the relationship of the fields of psychology, theology and Christian spirituality. It will explore the role of Biblical principles as related to human psychotherapy and the mental health field.

**MCC561 *Group Counseling* (3)**

The principles, dynamics and techniques of group therapy are examined. The focus will be on experiential, theoretical and practical aspects of group dynamics, processes and methodologies available to the family counselor. Special attention will be given to the developmental stages of groups and examining some of the facilitating roles of the leader.

**MCC563** *Theories of Psychotherapy* (3)

This course will examine the variety of psychotherapeutic orientations directly related to marriage and family therapy approaches to treatment.

**MCC564** *Abnormal Psychology* (3)

A course which examines the theories and issues of psychological maladies. Counseling and medical treatment is considered from the perspective of Christian worldview.

**MCC570** *Practicum I* (3)

This course will give field work experience to the student. It provides intern placement in a professional setting.

**MCC571** *Practicum II* (3)

This course will continue the fieldwork experience to the student. Additional integration of knowledge, skills and values as well as opportunities to assist the student in identifying personal and professional interests which will be of use in career decisions.

**MASTER OF ARTS IN CHRISTIAN EDUCATION**

**MCE500** *Research Methods* (3)

The course introduces the student to the process of scholarly inquiry in counseling, theology and ministry-related areas, including general, qualitative and quantitative research methodology. Also included is instruction on the preparation and presentation of academically researched papers and projects. Broad research approaches are examined. Special emphasis is given to the development of skills in using the library and its resources, and research writing. The course will include sample reading of counseling and theological literature and development of a model research paper.

**MCE502** *Introduction to Christian Education* (3)

A comprehensive treatment of the significance and scope of Christian Education: its definition nature, objectives, and procedures. This course will survey the field of Christian Education as applied in a local church setting.

**MCE503** *Christian Philosophy of Education* (3)

This course studies the major religions and secular developments in the philosophy of education. A comparison of those developments with biblical principles to develop an understanding of the church's role in education is provided.

**MCE510** *Cross-Cultural Education and Family Ministry* (3)

Advanced course dealing with marriage and family education and counseling integrated to principles and practice of cross-cultural education. Experiential learning approach to family ministry leaders' training designed to meet preventive and healing ministry in a scriptural context.

**MCE511** *Interpersonal and Intercultural Relationships* (3)



This course studies the development and maintenance of healthy relationship. Topics of discussion include application of Biblical principles to life situations, different personalities, development of skills in conflict management, and living in a group setting and being part of a team.

**MCE512** *Christian Family Life Education* (3)

A course designed for students to learn biblical family education in the Christian setting. Included is an emphasis on biblical principles of family and ways to apply biblical teaching in daily life.

**MCE513** *Child and Youth Education* (3)

A study of the basic principles underlying ministry to children and basic ministry principles and strategies to youth, ages 13-21, in the local church setting.

**MCE514** *Christian Marriage & Family Education* (3)

This course is an in-depth study of the definition, structure, function, theology and dynamics of family systems in relation to marriage and family education based on a Biblical foundation. From premarital education to marital relationships and parenting education, this course is focused on cultural variables related to communication, human intimacy and interpersonal dysfunctions studied from different perspectives. Topics include the various issues and crises such as mid-life crisis, divorce, death and long-term care in marriage and family life education.

**MCE520** *Parenting Education* (3)

This course studies principles in good parenting skills. Included are concepts of the mental, physical and emotional development of children.

**MCE521** *Child and Adolescent Development Psychology* (3)

A study of the psychological growth processes of children and adolescents. Included is an investigation of the theoretical and theological issues within the field of psychology.

**MCE522** *Adolescent Psychology* (3)

A study of the psychological growth processes of the adolescent. Included is an investigation of the theoretical and theological issues within the field of adolescent psychology.

**MCE530** *Child and Family Development* (3)

The study of human development across the life span which emphasizes a multidisciplinary perspective including such areas as psychology, sociology, processes as social interaction, and the tools for applying developmental psychology to life situations.

**MCE533** *Cultural and Ethnic Issues* (3)

This course studies the concepts, skills and attitudes useful in adapting to life in other cultures, including inter-cultural communication, values, customs, etc.

**MCE570** *Field Education I* (3)

An internship course designed to give potential Christian Education leadership and minister's practical training experience under the direction of a competent and experienced pastor or counselor.

**MCE571** *Field Education II (3)*

An internship course designed to give potential Christian Education leadership and minister's practical training experience under the direction of a competent and experienced pastor or counselor.

**BACHELOR OF ARTS IN COUNSELING**

**BAC211** *English Comprehension (3)*

Reading is power. Learning to read faster, more accurately, and with greater comprehension is a skill need in today. In today's world it is important than ever to understand how to draw meaning from what you read. Students and employees are actually required to read more than they ever have in the past, how-to books, technical manuals, and on-line reading resources. Whether the student already likes to read and simply wants to sharpen reading skills, or struggles with reading comprehension and speed, this course has something for everyone.

**BAC212** *English Writing Skills (3)*

This is a writing intensive course designed to help students practice the skills of close reading and critical analysis, for the improvement of one's writing abilities. Each week the students will be required to read assigned texts and respond to these texts through informal writing and class discussions. Three times during the semester, the students will write well-developed essays that will each go through an extensive process of peer revision before the completion of the final draft.

**BAC213** *English Interview Skills (3)*

This course provides students with a preliminary overview of the attitudes, knowledge, and skills which Human Resource professionals use when they conduct interviews. The students whose mother tongue is not English will have an opportunity to introduce themselves in English as they will practice interviewing skills taking the role of a client, the interviewee.

**BAC214** *Writing Documentation (3)*

This course provides students with writing skills of various documentation. Writing documentation is basic but needed knowledge and skills require training. This course covers writing skills from vita, intake sheet, reference letters, recommendation letters, syllabus, legal documentation, and other documentation. HIS University seeks to prepare bi-lingual counselors so students should know how to understand and write various documentation in Korean and English.

**BAC215** *Foundations of Research (3)*

This course presents basic concepts of descriptive statistics; probability distribution and inferential statistics (estimating parameters and testing hypotheses); sampling, experimental design, correlation and regression, consumer prices index.

**BAC217 *Science and Biology (3)***

This course focuses on cell structure and function. It provides students with a working knowledge of cellular organization; how cellular compartments are formed, how cells generate and utilize energy, how proteins are trafficked to the correct location and/or organelle within the cells. Students will learn how cells respond to their environment, how signaling pathways within the cell elicit specific cellular responses, how cytoskeleton components are assembled and how they regulate cell shape motility, how the cell duplicates and divides, how cells are organized into tissues, and how disruption of many of the above cellular processes can lead to cancer.

**BAC231 *General and Mathematical Foundations of Research (3)***

This course presents basic concepts of descriptive statistics; probability distribution and inferential statistics (estimating parameters and testing hypotheses); sampling, experimental design, correlation and regression, consumer prices index.

**BAC240 *Physical Education and Mental Health (3)***

This course provides opportunities for students to design and develop a personalized physical fitness program, participate regularly in health-enhancing physical activity beyond the physical education class, and meet the gender and age group health-related physical fitness standards. The students who are interested in mental health should understand how to take care of body as well as mind realizing the importance of the role of stewardship by God, our Lord. This course emphasizes on listening to our body.

**BAC251 *Theories of Counseling (3)***

This course is designed to study the current major counseling theories and the associated treatment modalities. Established schools will be studied and critiqued. This exploration includes the integration of the main psychological theories with biblical counseling. Psychodynamics, client center, existential, behavioral, and cognitive and Korean traditional theories will be examined.

**BAC258 *Developmental Psychology (3)***

This course provides a basic introduction to the milestones of human development from conception to late adulthood. The physical, cognitive, and social growth of people with special attention to various cultural contexts of development and the rich diversity of individuals are discussed. The content is drawn from research and theories in developmental psychology. Students are expected to integrate their personal experiences, knowledge of psychology, and observations of human development with the content of this course. In addition, implications for parenting, education, and psychotherapy are explored so students may apply course information to meaningful problems.

**BAC262 *Communication Skills* (3)**

This course provides students with the basic and practical skills for communication emphasizing interview skills basic to counseling. Verbal and non-verbal communication skills are included. The students learn how to have creative and healthy communication with family members, friends, co-workers, and clients in the private and public arena.

**BAC263 *Introduction to Abnormal Psychology* (3)**

This course explores the symptoms and causes of various types of psychological disorders – particularly the neurotic, psychotic, and mood disorders. A psychodynamic understanding of these abnormal conditions is emphasized. How abnormality is defined, assessed, and studied are important underlying issues. A variety of class exercises – including small group activities, group discussion, group presentations, internet DVD, and visitation to sites such as NAMI (National Alliance of Mental Illness), Village and/or other agencies and facilities.

**BAC264 *Introduction to Human Relationships* (3)**

This course provides for student learning in the arena of practical skills in human relationships through the experiential learning approach. Basic theory and principles of interpersonal relationships are presented. Students learn how to understand, to accept, and to appreciate differences from their own perspectives. Topics of discussion include application of different personalities, development skills in conflict management and living in a group setting and being part of a team. The students have an opportunity to understand themselves and others as a basic foundation of counseling.

**BAC265 *Child and Youth Counseling* (3)**

This course provides students with the basic knowledge and information about child and youth developmental theories, equipping them with education and tools for counseling children and youth. Students will understand children and youth according to their developmental stages and be able to assess them as to their development and growth into healthy adults physically, mentally, socially and spiritually through this course.

**BAC266 *Marriage and Family Counseling* (3)**

This course is in-depth study of family structure, function, and dynamics from a family systems perspective in relation to marriage and family counseling based on the biblical principles.

Assessment and techniques and analysis of marital relationships, with cultural variables including communication, human intimacy, and interpersonal dysfunctions, are studied from different perspectives.

**BAC267 *Legal, Ethical and Moral Issues in Counseling* (3)**

This course introduces students to moral foundations, ethical responsibilities, and California laws essential to the practice of counseling for children and youth. Ethical codes and the resolution of moral dilemmas are studied from the perspective of the Biblical ethical standards. This course deals with child abuse, domestic violence and other mandatory report issues according to the California laws on the mental health professionals.

**BAC271 *Practicum I* (3)**

Counselors need to have positive and healthy self-identification without unfinished business in their lives. Through this course, students have the opportunity to experience themselves being counseled as clients by professional, licensed counselors. The students will be able to learn the attitude and hearts of the counselors by their own experiences as clients.

**BAC272 *Practicum II* (3)**

Students majoring in counseling need field experience under the supervision of a qualified supervisor. The practicum sites may include agencies providing counseling services, nursery, preschool, kindergarten, private and public schools, and/or Sunday schools of local churches, mental health providers' private and public facilities with the school administration approval. Students will be evaluated by the site directors on their practicum and students will evaluate the site and their services according to their learning standards.

**BAC281 *Play Therapy* (3)**

Play therapy requires special knowledge and skills because of its unique theories and counseling skills. Children and youth counselors need to understand and to learn basic theories and skills training to enable a more effective counseling process. This course presents an overview of play therapy and its skills so that students will be motivated and challenged to learn more with awareness of their training needs. Students will understand the basic knowledge and skills of play therapy and will interact with research sources and information related to play therapy through this course.

**BAC283 *Marital Therapy* (3)**

This course deals with problems and conflicts within marriage and family settings using counseling methods and practical behavioral methods from a scriptural context designed to meet problems and conflicts conducted via demonstrations, case studies and counseling intervention. Students will learn how to counsel couples with marital conflicts through the experiential learning approach.

**BAC284 *Art Therapy* (3)**

Art therapy requires special knowledge and skills because of its unique theories and counseling skills. Children and youth counselors need to understand and to learn basic theories and skills training to enable a more effective counseling process. This course presents an overview of art therapy and its skills so that students will be motivated and challenged to learn more with awareness of their training needs. Students will understand the basic knowledge and skills of art therapy and will interact with research sources and information related to art therapy through this course.

**BAC286 *Parenting Education and Counseling* (3)**

Children and youth counselors need to learn the basic principles and skills of parenting in order to help parents raise their children in more effective and healthy ways. This course provides students with the biblical way of raising children and psychological integration with parenting skills. Students will gain some insight and research foundations to be able to prepare and teach a parenting class in the setting of a local church.

**BAC 300** *Introduction to Research Methods* (3)

Research skills for use of the internet, library and reference works in counseling and Bible. Methods of writing with emphasis on critical thinking, persuasion and evaluation are covered, culminating in research paper written in APA style and oral presentation. This course has no prerequisite courses.

**BAC 310** *Foundations of Christian Counseling* (3)

This course explores developments within the Christian counseling movement. It examines the nature of the client and the counselor as well as various settings in which counseling skills may be used. Methods of gathering useful data are examined. General methods in group and individual counseling are discussed with emphasis on self-awareness development, characteristics and techniques to be used by the counselor in interviewing and counseling in Christian, secular and multicultural environments.

**BAC411** *Premarital Counseling* (3)

A study of compatibility and readiness for marriage. Focus is placed on areas to explore with couples either prior to or after engagement. This course includes an introduction to the assessment tools most commonly used in premarital counseling.

**BAC412** *Biblical Foundations of Marriage and Family* (3)

A psychologically and theologically integrated study of marriage and family relationships, prepares students to develop a personal philosophy of family and to set the foundation for the development of a family ministry within the church. The course includes a personal evaluation of student's familial experiences and a challenging look at cultural norms and biblical principles. This skill building course prepares students for participation in leadership of family life.

**BAC420** *Introduction to Child Counseling* (3)

This course provides an introduction to the basics of counseling children. The course will emphasize a survey of developmentally appropriate individual and systemic counseling approaches for children.

**BAC421** *Introduction to Adolescent Counseling* (3)

This course is an introduction to the basics of counseling adolescents. The course will emphasize a survey of developmentally appropriate individual and experiential counseling approaches for adolescents.

**BAC430** *Counseling Seminar* (3)

The student will participate in a conference on current issues in counseling. The professor will choose from a variety of Christian counseling and psychology conferences available which one the students will attend. Conference fees are paid in addition to student tuition.

**BAC431** *Special Topics in Counseling* (3)

Numerous available workshops providing foundations for a variety of counseling topics such as child and spousal abuse, alcoholism and substance abuse, domestic violence, crisis counseling and others. Workshops change from semester to semester.

**BAC450 *Introduction to Psychology* (3)**

This is a survey of psychology as an empirical/behavioral science with a consideration of underlying philosophical bases in light of a Christian world view. Topics to be surveyed include development, cognition, learning, motivation, physiology, socialization, personality and psychopathology.

**BAC451 *Developmental Psychology* (3)**

This course is a study of the theory and research concerning lifespan development. Consideration will be given to the physical, emotional, cognitive, social and moral aspects of human development across the entire span from conception to death. Discussion will include timely issues of personal relevance to the student's own developmental pathway.

**BAC452 *Abnormal Psychology* (3)**

This course examines the nature, causes and treatment of abnormal behavior, including the full range of mental disorders identified within current categorical systems.

**BAC460 *Human Relationship* (3)**

An explanation of humanity's relational nature as it reflects God's relational nature. Health in a variety of relational contexts will be explored. Self-awareness as well as implications of ministry to others is emphasized.

**BAC470 *Personality Theory* (3)**

An overview of personality theories including the primary representatives of the major schools: analytic or dynamic, humanistic-existential and behavioral. An integrative model will also be presented.

**BAC480 *Foundations of Psychotherapy* (3)**

This course provides an introduction to the theory and techniques of psychotherapy. It includes an overview of various approaches to psychotherapy and a discussion of foundational therapeutic techniques.

**BBS201 *Biblical Integration in Counseling* (3)**

This course provides the students with the basic concepts on biblical integration in counseling. There are different views on psychotherapy and counseling among Christians. The students are trained to read the Bible in the light of counseling with meditation and integration to counseling. This course also introduces the history of integration of the Bible in counseling and some models of Christian counselors who integrate biblical philosophy and worldview in the counseling process.

**BBS202 *Spirituality in Therapy* (3)**

Through the reading, reflective journaling, presentations, respectful dialogue, and exploration of the Scriptures, spiritual traditions and practices, the class aims to provide a general introduction to the various books of the Bible. Each semester a different book will be studied.

This course provides opportunity for the student to discover family issues within the biblical text at the time the Scriptures were written, discover how the biblical writers addressed these issues and how this applies to counseling issues and foundations today.

**BBS220** *New Testament Survey (3)*

This course surveys the complete New Testament inclusive of the historical and cultural context including the Intertestamental period in order to gain knowledge of the life of Christ, the establishment of the church, and the teachings concerning the believer's faith and practice. This course has no prerequisite courses.

**BBS230** *Old Testament Survey (3)*

The purpose of Old Testament Survey is as a general introduction to the Old Testament books. Emphasis is placed upon gaining an overview of the Old Testament through a survey of geographical and historical backgrounds and a book-by-book study. Attention is given to the structure of each biblical book, significant interpretative problems, and major theological themes. This course has no prerequisite courses.

**ASSOCIATE OF ARTS IN COUNSELING**

**AAD 211** *English Comprehension (3)*

Reading is power. Learning to read faster, more accurately, and with greater comprehension is a skill needed in today. In today's world it is important than ever to understand how to draw meaning from what is read. Students and employees are actually required to read more than they ever have in the past, how-to books, technical manuals, and on-line reading resources. **ABS201 *Biblical Integration in Counseling* (3)**

This course provides the students with the basic concepts on biblical integration in counseling. There are different views on psychotherapy and counseling among Christians. The students are trained to read the Bible in the light of counseling with meditation on integration to counseling. This course also introduces the history of integration of the Bible in counseling and some models of Christian counselors who integrate biblical philosophy and worldview in the counseling process.

**ABS202 *Spirituality in Therapy* (3)**

Through the reading, reflective journaling, presentations, respectful dialogue, and exploration of the Scriptures, spiritual traditions and practices, the class aims to provide a general

introduction to the various books of the Bible. Each semester a different book will be studied. This course provides opportunity for the student to discover family issues within the biblical text at the time the Scriptures were written, discover how the biblical writers addressed these issues and how this applies to counseling issues and foundations today.

### **DIPLOMA IN PEER COUNSELING**

#### **DCC101 *Basic Counseling Skills* (3)**

This is an introduction to the study of human behavior and the development and maintenance of healthy relationships. Theories and research on the helping relationships are explored.

#### **DCC102 *Christian Counseling and Life Development* (3)**

This course is designed to study the development and maintenance of healthy relationships. Topics of discussion include application of biblical principles to life situations, different personalities, and development of skills in conflict management, living in a group setting and being part of a team.

#### **DCC103 *Christian Marriage and Family Counseling* (3)**

This is a study of the biblical principles of marriage and family and students learn how to counsel those in crisis.

#### **DCC104 *Communication Skills* (3)**

This course studies the elements of communicating in the private and public arena.

#### **DCC105 *Family Therapy* (3)**

This is a study and practical application of biblical and counseling techniques in the family counseling arena.

#### **DCC140 *Special Topics: Child Abuse Workshop* (1)**

This workshop fulfills the Board of Behavioral Sciences 7- hour requirement for training on ways to provide services to victims of child abuse. Also examined are contexts for child abuse, historical precedents and other sociological factors of child abuse and an examination of Christian faith and its response to child abuse.

#### **DCC141 *Special Topics: Alcoholism and Substance Abuse* (3)**

Special courses offer graduate level content that is typically scheduled in an intensive format. These courses include a range of specialized topics that are of interest to mental health professionals. Among these topics is the Substance Abuse Course. Courses range from 1 to 6 units depending upon the specific contact hours and workload involved in the course.

#### **DCC142 *Special Topics: Domestic Violence Workshop* (1)**

The topics of this workshop include the effects of domestic violence on adults and children, practical counseling solutions, legal issues, and social factors of domestic violence in the context of Christian faith.

Preventative strategies against domestic violence are explored.

**DCC143** *Special Topics: Psychopharmacology (2)*

This topic discusses the various pharmaceutical drugs and their appropriate use in cooperation with counseling in the treatment of psychological disorders.

**DCC 180** *Practicum (3)*

This course gives fieldwork experience to the student. It provides intern placement in a professional setting. The aim is to provide an opportunity for the integration of knowledge, skills, and values as well as opportunities to assist the student in identifying personal and professional interests which will be of use in career decisions.

**DCC 511** *Interpersonal and Intercultural Relationships (3)*

This course studies the development and maintenance of healthy relationships. Topics of discussion include application of biblical principles to life situations, different personalities, development of skills in conflict management, and living in a group setting and being part of a team.

**DCC520** *Parenting Education (3)*

This course studies the principles in good parenting skills. Included are concepts related to the mental, physical, and emotional development of children.

**DCC533** *Child and Adolescent Therapy (3)*

This course provides an understanding of the broad range of childhood and adolescent problems and disorders. A variety of psychotherapeutic modalities is presented, offering the student an opportunity to develop knowledge of basic child and adolescent therapy skills, assessments, and treatment strategies.

**DCC556** *Group Counseling (3)*

The principles, dynamics and techniques of group therapy are examined. The focus will be on experiential, theoretical and practical aspects of group dynamics, processes and methodologies available to the family counselor. Special attention will be given to the developmental stages of groups and examining some of the facilitating roles of the leader.

**DCC560** *Christian Counseling and Psychotherapy (3)*

This course will examine the common bond between psychology and the Christian faith. It will explore the role of biblical principles as related to human psychotherapy and the health field.

## COMMUNITY AGREEMENTS

Biblically speaking, the following behavioral expectations apply to all members of the HIS University community:

1. Those acts, which are expressly forbidden in Scripture, including: premarital/extramarital sex, homosexuality, drunkenness, theft, profanity, occult practices, and dishonesty will not be practiced by members of this community.
2. Other areas the community is expected to avoid are known as “sins of the spirit” and “sins of the tongue.” These include such sins as covetousness, jealousy, pride, lust, envy, immodesty, impatience, backbiting, enmity, strife, outbursts of anger, factions, bitterness, an unforgiving spirit, slander, discrimination and prejudice (Jeremiah 9:3-9, Mark 7:20-23, Galatians 5:12-21). Although these issues are more difficult to discern, they can be destructive to the healthy functioning of the community.
3. Recognizing the Christian obligation to submit to the governing authorities (Romans 13:1, 1 Peter 2:13), individuals related to HIS University are expected to uphold the laws of the local community, the state and the nation.

*In addition to those behaviors and attitudes which the Scriptures specifically praise or condemn, the HIS Board has adopted the following statement of community agreements which are a requirement for membership in the HIS community.*

*HIS University is a community of Christians committed to the principles of Christian living found in the Bible and holds that these biblical standards are vital to our individual and corporate relationships. Maintaining these standards contributes to the kind of atmosphere in which quality Christian and secular communities. In this light, and given the clear biblical imperative for spiritual self-discipline, the university has established these “standards of conduct” to be observed and upheld, by all members of the HIS community.*

*Consistent with the example and command of Jesus Christ, we believe that life within a Christian community must be lived to the glory of God, with love for God and for our neighbors. Being indwelt by the Holy Spirit, we strive to walk by the Spirit, ‘crucifying the flesh with its passions and desires’ (Galatians 5:24). To this end, members of the HIS community are not to engage in activities which Scripture forbids. Such activities include, but are not limited to, dishonesty, thievery, fornication, adultery, homosexual practice, drunkenness and unscriptural divorce. Scripture also condemns other “deeds of the flesh” such as covetousness, jealousy, pride and lust – sins which the maturing Christian should put off, and replace with the “fruit of the Spirit”: Love, joy, peace, patience, kindness, goodness, faithfulness, gentleness and self-control (e.g., Luke 10:27; Galatians 2:20, 5:14-24; Ephesians 2:3; 1 Corinthians 6:9-10).*

*As a Christian educational institution, HIS also recognized the responsibility of its board of trustees, faculty and staff to provide examples of maturing Christian character conduct to its students and the community at large. To this end, participation in certain practices has been traditionally held by the University to be inappropriate for members of the HIS community. Such practices relate to areas of personal discipline and are in keeping with the biblical admonition that Christians glorify God in their physical bodies as “the temple of the Holy Spirit” (1 Corinthians 6:19-20), and that their freedom in Christ must not cause a brother or sister in Christ to stumble (1 Corinthians 8:7-13; 10:23-33). Members of the HIS community are expected to refrain from the use of alcoholic beverages and tobacco in any form, and from gambling. Also, HIS does not allow social dancing and university-related or sponsored activities (that is, at any activities that involved any identifiable university group, is publicized on campus and/or has the appearance of being university-related, whether held on or off campus). HIS University does not presume to be a censoring agency for all activities; however, it does expect tangible evidence of maturing Christian convictions and discerning judgment.*

*In addition, members of the HIS community will observe Sunday as the Lord’s Day and give primary attention to worship, rest, Christian fellowship and recreation and service.*

These standards apply to the student while enrolled in any of the schools or programs of the university on and off campus. In addition, these standards apply to the board members during their terms of service on the HIS University Board, and to faculty and staff during their terms of employment with HIS University. HIS therefore reserves the right to discipline or dismiss any student or employee who, in its judgment, does not conform to these conduct standards or to other expressed principles, policies, programs and expectations of the university governing employee conduct.

## HIS UNIVERSITY'S DOCTRINAL STATEMENT

Inasmuch as the University is interdenominational and yet theologically conservative, a doctrinal statement is given below:

The Bible, consisting of all the books of the Old and New Testaments, is the Word of God, a supernaturally given revelation from God Himself, concerning Himself, His being, nature, character, will and purposes; and concerning man, his nature, need and duty and destiny. The Scriptures of the Old and New Testaments are without error or misstatement in their moral and spiritual teaching and record of historical facts. They are without error or defect of any kind.

There is one God, eternally existing and manifesting Himself to us in three Persons – Father, Son and Holy Spirit.

Our Lord Jesus was supernaturally conceived by the power of the Holy Spirit and born of a virgin – Mary, a lineal descendant of David. He lived and taught and did mighty works and wonders and signs exactly as is recorded in the four Gospels. He was put to death by crucifixion under Pontius Pilate. God raised from the dead the body that had been nailed to the cross. The Lord Jesus, after His crucifixion, showed Himself to be alive to His disciples, appearing to them by the space of 40 days after his resurrection. After this, the Lord Jesus ascended into heaven, and the Father caused Him to sit at His right hand in the heavenly places, far above all rule and authority and power and dominion, and every name that is named, not only in this world, but also in the world, which is to come, and put all things in subjection under His feet, and gave Him to be Head over all things to the Church.

The Lord Jesus, before His incarnation, existed in the form of God and, by His own choice, laid aside His divine glory, took upon Himself the form of a servant, and was made in the likeness of men. In His pre-existent state, He was with God and was God. He is a divine person possessed of all the attributes of Deity, and should be worshiped as God by angels and man. "In Him dwells all the fullness of the Godhead bodily." (Colossians 2:9 KJV) All the words that He spoke during His earthly life were the words of God. There is absolutely no error of any kind in them, and by the words of Jesus Christ the words of all other teachers must be tested.

The Lord Jesus became in every respect a real man, possessed of all the essential characteristics of human nature.

By His death on the cross, the Lord Jesus made a perfect atonement for sin, by which the wrath of God against sinners is appeased and a ground furnished upon which God can deal in mercy with sinners. He redeemed us from the curse of the law by becoming a curse in our place. He, who Himself was absolutely without sin, was made to be sin on our behalf that we might become the righteousness of God in Him. The Lord Jesus is coming again to his earth, personally, bodily, and visibly. The return of our Lord is the blessed hope of the believer, and in it God's purposes of grace toward mankind will find their consummation.

The Holy Spirit is a person of the Godhead. He possesses of all the distinctively divine attributes. He is God.

Man was created in the image of God, after His likeness, but the whole human race fell in the fall of the first Adam. All men, until they accept the Lord Jesus as their personal Savior, are lost, darkened in their understanding, alienated from the life of God through the ignorance that is in them, hardened in heart, morally and spiritually dead through their trespasses and sins. They cannot see, nor enter the Kingdom of God until they are born again of the Holy Spirit.

Men are justified on the simple and single ground of the shed blood of Christ and upon the simple and single condition of faith in Him who shed the blood, and are born again by the quickening, renewing, cleansing work of the Holy Spirit, through the instrumentality of the Word of God.

All those who receive Jesus Christ as their Savior and their Lord, and who confess Him as such before their fellow men, become children of God and receive eternal life. They become heirs of God and joint-heirs with Jesus Christ. At death, their spirits depart to be with Christ in conscious blessedness, and at the Second Coming of Christ, their bodies shall be raised and transformed into the likeness of the body of His glory.

All those who persistently reject Jesus Christ in the present life shall be raised from the dead and throughout eternity exist in the state of conscious, unutterable, endless torment and anguish.

The Church consists of all those who, in this present dispensation, truly believe in Jesus Christ. It is the body and bride of Christ, which Christ loves and for which He has given Himself.

There is a personal devil, a being of great cunning and power: "The prince of the power of the air," "The prince of this world," "The god of this age." He can exert vast power only so far as God suffers him to do so. He shall ultimately be cast into the lake of fire and brimstone and shall be tormented day and night forever.

*Note: This doctrinal statement, presented here as originally written, has been and continues to be the stated theological position of HIS University. Where "man" is used, referring to the human race, it includes both genders. In addition, the following explanatory notes indicate the organization's understanding and teaching position on certain points, which could be subject to various interpretations:*

- ☐ The Scriptures are to be interpreted according to the conviction that the return of the Lord for His Church will be premillennial, before the Tribulation.
- ☐ The existence of the Creation is not explainable apart from the roles of God as the sovereign Creator and Sustainer of the entire natural realm. Concepts such as theistic or threshold evolution do not adequately explain creation.
- ☐ Though there may be many fillings of the Holy Spirit, there is only one baptism, which occurs at the time of regeneration. The gifts of the Spirit are given to believers according to the will of God for the purpose of building up the Church. During the foundational era of the Church (i.e., the time of Christ and the Apostles) God gave special manifestations of the overtly supernatural and miraculous gifts (e.g., tongues, healings, miracles) as "signs" that witness to the validity of those bearing new canonical revelation (c.f. 2 Cor. 12:12; Heb. 2:3-4). Beyond the foundational era, God in His sovereignty may grant any spiritual gift and work miraculously for the benefit of His Church at any time.
- ☐ The Bible is clear in its teaching on the sanctity of human life. Life begins at conception. We abhor the destruction of innocent life through abortion-on-demand.
- ☐ Confession before men is viewed as tangible fruit of salvation and not as a qualifying condition for salvation.
